I will not hold the City of Campbell River, Campbell River Shoreline Arts Society, Sponsors, Volunteers (the "Parties"), or any of the membership liable for personal injury or loss of tools and equipment at or during the competitions.

I hereby agree to permit Campbell River Shoreline Arts Society to use any photographs and/or images, taken by their photographer for any promotional or fundraising purpose for Campbell River Shoreline Arts Society.

I fully understand and agree to abide by the Rules set out by Campbell River Shoreline Arts Society and agree to the above waiver.
